Dear members,


It's a new year, and the Alumni Association has a new Executive Committee! In this issue, we profile all members of the EC. Also look out for yet another featured alumnus.

He envisions a grand future for the Alumni Association and has been a ke member of the Executive Committee since its inception.




Sr. Vice President V. Shekhar B. Com *1977*

Vice President Rajneesh Kochhar BA (Hons) English 1989


A consultant for Auto Components Exports, by profession, a traveller at heart.

Joint Secretary R. Kasturika B.Com (Hons) 2009


Designer by day, blogger by night. Kasturika loves to sing, sketch, read and write.


Raman enjoys & regularly undertakes nature trails and is passionate about photography and Indian Classical music.

Executive Member Pankaj Rakesh B.Com (Hons) 1984


Inaneventfulcareer spanning over three decades, Pankaj has accumulated skill sets in varied aspects of electronic and print media as well as in filmmaking.
