- 1. I welcome all the members to the 5th AGM of the Alumni Association of Shaheed Bhagat Singh College.
- 2. I also have the pleasure of presenting to you, on behalf of the Executive committee, the President's Annual Report of the Alumni Association Shaheed Bhagat Singh College.
- 3. At the outset, let me say that the Alumni Association has been in existence for over 4 years and we have made significant progress in laying a solid foundation of the same as is evident from the following achievements:
 - a. Finalization of objectives, rules and regulations
 - b. Registration under Society Act.
 - c. Exemption of Income(12A) and Registration under section 80G under Income Tax Act
 - d. Enrollment of 1484 members and their records.
 - e. Development of website and brochure.
 - f. Monthly Newsletter
 - g. Events for students and members
 - h. Regular meetings of EC & AGM
 - i. Interaction with Principal
 - j. Digitization of records of Pass outs
 - k. Annual scholarship to meritorious students
 - l. Initiation of honoring alumni
 - m. Regular maintenance of books of account and audit.

- 4. The Audited statement of accounts consisting of Balance sheet, Income & Expenditure and Receipt & Payments Account along with the Auditors report for the year ended/as on March 31, 2014 are presented to you for your consideration and approval. The highlights of these accounts are:
 - Corpus fund of members and Cash & Bank balances has increased from Rs. 3.74 lacs(previous year) to Rs. 4.08 lacs in the current year.
 - Excess of income over expenditure and cash & bank aggregates to Rs. 0.34 lacs and Rs. 3.86 lacs respectively.
- 5. The stage is now set for the Association to take the next big steps towards the following initiatives:
 - a. Increase the membership to atleast 3000 in next two years
 - b. Assist and participate in the major initiatives of college such as the Golden jubilee celebration, building of auditorium etc.
 - c. Identify source of funding/sponsorships for various activities. Also explore the possibility of CSR
 - d. Placement of students in various organizations.
 - e. Increase the participation of members and students in the events of the association.
 - f. Engagement with NGO's and other institutions for charitable, community service and skill development for students and members.
 - g. Recognize outstanding academic, social and community services by Alumni and students.
- 6. As you are aware that the term of the 2nd EC will end in this AGM and members will elect a new EC. I take this opportunity to thank Dr. Khurana, Principal, teachers and staff of the college for their assistance and cooperation to the association. Also my colleagues in the EC have been a continuous source of motivation.
