I, as First President of Alumni Association of Shaheed Bhagat Singh College have pleasure in presenting this Second Annual Report of the Association together with :-

- (a) Audited Balance Sheet of the Association as on 31st March, 2011.
- (b) Income and Expenditure Account for the period 16th April, 2010 to 31st March, 2011.
- (c) Receipts and Payments Account for the period 16th April, 2010 to 31st March, 2011.

MEMBERSHIP SINCE LAUNCH OF THE ASSOCIATION

You are all aware that our Association was formally launched at an impressive ceremony in the College premises on 2nd May, 2010 in presence of the College Principal and a large number of present and former Professors of the College. Although, on that day only 20 Alumni had registered themselves as members, however, soon after the formation of the First Executive Committee, hectic efforts were made by all concerned to increase the membership and I am glad to report that at the close of the Financial Year under review, as many as 138 alumni had enrolled themselves by paying the prescribed Life Membership Fee of Rs.500/- each. Since such Associations cannot do full justice to the objects for which they are set up, until and unless a large number of members enrol themselves, through this report I appeal to each one of you to put in your best by ensuring that the various ex-students of the College known to you are informed about this important development and are requested to become members of this Association by complying with the formalities prescribed for the purpose.

FINANCIAL PERFORMANCE

As can be glanced from the Receipt and Payment Account for the period from 16th April, 2010 to 31st March, 2011 annexed herewith, your Association, apart from having received an aggregate subscription of Rs.69,000/- from 138 Life Members, received a one time initial contribution of Rs.50,000/- from the College and Rs.1.01 Lacs as donation, contributed by some of the members of the present Executive Committee. Since after meeting the day to day expenses of the Association, some surplus cash was available with the

Association, an amount of Rs.1 Lac was placed with the Association's Bankers to earn higher interest than the one usually permitted on Savings Account.

As far as income of the Association during the year under report is concerned, from a total income of Rs.1.74 Lacs, after meeting an expense of Rs.70,000/-, an income of Rs.1.04 Lacs was generated till the end of the last Financial Year ended on 31st March, 2011.

PROGRESS SINCE INCEPTION

1. EXECUTIVE COMMITTEE

As all of you are aware, at the time of formal launching of the Association in the College Premises on Sunday, the 2nd May, 2010, 20 members were nominated on the Executive Committee to manage the affairs of the Association till the time the Association comes out of its infancy and elections are held from the then existing members to occupy the different positions of the Executive Committee to further the objectives of the Association thereafter.

2. OPENING OF BANK ACCOUNT

In order to ensure complete transparency in the accounts of the Association, your Executive Committee soon after its launch opened a Bank Account bearing No.355702011683113 for the Association under the name and style of **“Shaheed Bhagat Singh College Alumni Association”** with Kailash

Colony Extension Counter Branch of Union Bank of India, who also happens to be the Bankers of the Shaheed Bhagat Singh College. Since then, barring some cash required for imprest, all the receipts of the Association are banked with the said Bank and most of the payments are made through cheques.

3. CONSTITUTION AND RULES & REGULATIONS

While the broad constitution as approved by the Executive Committee of Shaheed Bhagat Singh College was put in place on the inception itself, detailed Rules & Regulations of the Association were, after approval by the Executive Committee, duly registered as a “Society” under Society Registration Act with the ... registration no. S/420/Distt.South/2011 dated 29th March 2011.

4. MEETINGS OF GOVERNING BODY

So far as many as 10 meetings of Governing Body have been convened wherein apart from taking decisions on certain policy matters, periodic financial statements were also approved. These meetings were held on :-

5. NEW MEMBERSHIP

I am indeed glad to report that some of the Senior Professors of the College including Dr. S.B. Saxena, Dr. A. P. Gupta, Dr. Anil Sardana and Dr. Poonam Sharma left no stones unturned to convince the outgoing students representing the last batch of the College to join the Alumni Association after passing out. It is mainly because of their efforts only that 482 students expressed their desire to join the Association by giving their consent to transfer of their Security Deposit of Rs.500/- each with the College to the Association as their Life Membership Subscription. If similar practice is repeated in the years to follow also, each year approximately 500 outgoing students would join the Association.

6. RECENT ACTIVITIES

A) ON ACADEMIC FRONT

Since the Governing Body of the Alumni Association was keen to have a direct interaction with the students of the College and help them not only in their career counselling, but even for upliftment of their knowledge base, few

The dinner was attended by large number of Alumni and Professors. Apart from tremendous emotional satisfaction that all the members present thereat derived by meeting old Professors after a gap of many years, a spectacular fire works was also organised at the Venue by Mr. Nikhil Dujari.

(II) FAREWELL TO THE OUTGOING PRINCIPAL AND WELCOME OF THE NEW PRINCIPAL

As Dr. B. C. Sehgal, the Officiating Principal of the College superannuated after rendering a dedicated service of more than 35 years to the College, the members of Executive Committee, in order to pay their personal regards to him, organised a splendid contributory dinner on 17th October, 2011 at India Habitat Centre, which was attended by most of the Executive Committee Members with their spouses.

It was also an appropriate event to formally welcome the incoming Principal Dr. Gulshan Kapoor in the same dinner. Both Dr. Sehgal and Dr. Kapoor, while speaking about the performance of Association, blessed Executive Committee Members, who all have been their ex-students. Dr. Gulshan Kapoor, while doing so, committed his complete support from College for all the future activities of the Association.

7. FUTURE PLANS

A) SCHOLARSHIP SCHEME

In order to encourage meritorious students of the College, your Executive Committee has decided to grant Scholarships up to an aggregate amount of Rs.8,000/- every year to few deserving students recommended by the College. In order to adhere to the relevant norms and practices followed by the College

for grant of such scholarships, an amount of Rs.1 Lac has been donated by the Association to the College.

B) INTERACTIVE PROGRAMMES

The Executive Committee, in one of its recent meetings took a decision to frequently hold such interactive programmes where the student community as well as the faculty get a chance to directly interact with certain celebrities of the city from different vocations/ disciplines, reputed lawyers & highly placed Govt. officers. The Executive Committee members will use their respective personal contacts with such personalities to ensure that such programmes are grand success.

C) EXEMPTIONS FROM INCOME TAX

Although tax exemptions to the Donors for the donations made by them to the Association may not get necessary permission in accordance with Section 80 G because of the fact that the activities of the Association may not be treated as “Charitable”, your Executive Committee is making hectic efforts to get the necessary exemptions of tax for the income earned by the Association. The General Secretary of the Association Mr. Harinderjit Singh has been delegated with full authority to make necessary efforts in this direction.

D) NEWS LETTER

As the number of members of the Association is gradually increasing, a need has been felt to initiate an electronic News Letter of the Association wherein,

apart from necessary information pertaining to the activities of the Association, vital information about the members of the Association is proposed to be circulated.

Friends, I hope you will agree with me that within a short span of approximately 18 months since the inception of the Association, a lot has been achieved in spite of certain teething problems that it faced being an absolutely new entity. Your Executive Committee is fully confident that keeping in view the vast resources that most of the ex-students of the College have at their command, the day is not far when the Alumni Association of Shaheed Bhagat Singh College will be an unparalleled example for the other similar Associations.
