### **PRESIDENT'S REPORT**

- 1. I welcome all the members to the 8<sup>th</sup> AGM of the Alumni Association of Shaheed Bhagat Singh College.*
- 2. I have the pleasure of presenting to you, on behalf of the Executive committee (EC), the President's Annual Report of the Alumni Association Shaheed Bhagat Singh College.*
- 3. At the outset, The Alumni Association has been in existence for around 7 years and we have made significant progress in laying a solid foundation of the same as is evident from the following initiatives:*
  - Finalization of objectives, rules and regulations as amended to date*
  - Registration under Society Act.*
  - Exemption of Income(12A) and Registration under section 80G under Income Tax Act*
  - Total number of members in the Alumni Association are 3802.*
  - Development of website and Brochure.*
  - Monthly Newsletter*
  - Events for students and members*
  - Regular meetings of EC & AGM*
  - Regular Interaction with Principal and other teachers*
  - Annual scholarship to meritorious students*
  - Honouring distinguished alumni and past teachers*
  - Regular maintenance of books of account and audit.*
  - Active on social media such as facebook which has more than 2000 followers.*

**4. Workshops conducted for the students in the past year included**

- a) **Skill development** : Skill development was successfully held on 17<sup>th</sup> Jan 2017. The students appreciated the experiences shared by the three distinguished speakers - Mr. Rajinder Sud, Mr. Anubhav Wadhwa and Mr. Sunil Malhotra, on the subjects of Build a successful career (Be a Rockstar), Business Plan and success story and Design Thinking respectively.
- b) **Media** : The workshop was about encouraging the students for taking media as a career option and how the seniors in the profession could mentor the new entrants. Mr. Pankaj Rakesh (EC member) and Mr. Srivastava were the two speakers and facilitators.
- c) **Cybercrime** : The discussion centred on vulnerability of various day to day applications used by all of us (including whats app) towards cybercrime, relevant legal provisions and psychology of the affected people. The distinguished speaker was Mr. Pawan Duggal.

**5. During the year, the events organized by the association for the members included :**

- a) **Spring Reunion 2017** – The Spring Reunion 2017 was held in Shri Sathya Sai Auditorium, Pragati Vihar, Lodhi Road, New Delhi on 25<sup>th</sup> March 2017. Bollywood musician, composer and singer Shankar Sawhney accompanied by singers from Indian Idol show gave an excellent performance and were well appreciated by the members and students.
- b) **Golden Jubilee Celebrations of the College**: The Golden jubilee of the College was organized on 16 July 2017 at SiriFort Auditorium, Khelgaon, New Delhi. The distinguished alumni of the college were felicitated by the College at the function for their services provided in their various fields of profession to the college.
- c) The Association conducted a **Workshop on GST** to make the members and students aware and to have applied knowledge of the subject. Ms. Anita Rastogi, PwC Partner and CA Arun Gupta conducted the workshop in PHD House, Raunaq Hall, and New Delhi on 10<sup>th</sup> Aug 2017 which included a session on Q & A session.
- d) **Annual Dinner for Members'**: The Annual Dinner for members is planned on 19<sup>th</sup> November 2017. The spouses of the members will participate in the event. The highlights of the evening would be participation of new members, a video on the activities of the Association to date, live music and interaction among members along with some fun & games.

**6. The Audited statement of accounts consisting of Balance sheet, Income & Expenditure and Receipt & Payments Account along with the Auditors report for the year ended / as on March 31, 2017 are presented to you for your consideration and approval.**

The highlight of these accounts are:

- Corpus fund of members is Rs. 6.81 lakhs
- Excess of Income over Expense aggregates to Rs 3.52 lakhs

- *Cash and Bank balances amount to Rs. 7.68 lakhs (including Rs. 3.09 lakhs in FDs and Rs. 4.42 lakhs in savings.)*
  - *Donations amounted to Rs. 5.04 lacs.*

  - e. Identify source of funding/sponsorships for various activities.*
  - f. Increase the participation of members and students in the events of the association.*
  - g. Engagement with NGO's and other institutions for charitable, community service and skill development for students and members and the related CSR activities.*
  - h. Recognize outstanding academic, social and community services by Alumni and students.*
  - i. Networking, knowledge sharing and social events for the members.*
  - j. Connect with 3<sup>rd</sup> year students of the college for involving them as future members and in the activities of the Association.*
