
A strong and vibrant Alumni Association is an asset of any educational institution. Hence

It was 16th of July, 1969 that a group of new recruits joined the faculty of Shaheed Bhagat Singh College including me, Dr. S. B. Saxena, Mr. O.M. Agarwal, et.al. Soon we became friends with our seniors Prof. Sydney Rebeiro, A. P. Sudhir, Prof Gurdarshan Singh, Prof. J. K. Mukhi, Prof. R.S. Agarwal, Prof. T.R. Arora.




Wonderful time we had. Watching films, sometimes two to three shows in a day. Playing cricket under the captaincy of Prof. Sydney and then Intercollege matches, thanks to Prof. A.P. Gupta and Dr. S. S. Sareen.

Being the initial period, settling at teaching was no easy with the kind of crop Shaheed Bhagat Singh college, like any other college, in its infancy has. Students like Sher Singh Dagar, along with his brigade, will enter the class and I remember will rub their shoes against the floor creating an embarrassing situation. It took me some time in settling down. Initially, I was given to teach Scientific Methods (Deductive and Inductive Logic). Somehow was able to manage. Then I got to teach Mercantile law. My biggest mistake, I recommended the same book to the students which I was referring. Students felt quite unhappy since I was not offering them anything beyond the book. Felt disheartened and dejected. Spoke to Prof. S.S. Gulshan, the then Head of the Department of Commerce, that I wanted to resign. When I told him the reason, he said, as a teacher, never recommend the book, you use to prepare your notes. Since then, there was no looking back. Trick worked not only at Shaeed Bhagat Singh College but also elsewhere, so much so that I earned the reputation of being a very good teacher of Business and Corporate law and also earned Best Teacher award from NIRC of the Institute of Chartered Accountants of India as well as Excellence award from Amity University, Management School. Besides, I enjoy the status of Professor of Business and Corporate Laws at the International Management Institute, New Delhi, a premier Business School.

Some of my favorite students, whom I shall always remember, include Ghanshyam Gehani, Deepak Kapoor, Harinderjit Singh, Nikhil Dujari, Dr. Anil Sardana and many more whom I remember by their face but cannot recall their names. Will ever remain indebted to them, through their inquisitiveness, for making me what I am today.

Thank Bhagat Singh college Alumni for making meeting of the old pals, teachers and students possible. Wish they organize such events more often.

I joined Bhagat Singh college (not SBS college as now) in the year 1970 in commerce deptt. I was a shy girl of 21 yrs straight out of Delhi School of Economics after completing my post graduation. I was the only lady lecturer in my deptt with a strength of around 30 lecturers and continued to remain so for more than 20 yrs till Kalpana joined. On many occasions I was



compelled to sacrifice my participation in departmental activities owing to absence of a lady colleague.

During those days our principal Dr Thakore used to host dinner parties for the freshly appointed teachers at his residence. I had the privilege of attending two such dinners as my name got included in the list of teachers next year as well. This could have been by mistake on someone s part but being new n inexperienced I thought it was not advisable to defy The principal 's invitation. As a result I had a second chance to enjoy the lavish dinner at Dr Thakore's House.

I need not mention how special I was made to feel that evening by our principal and his wife. The memories of those early years in my teaching career make me awfully nostalgic.

When I was approached by my dear friend Harinderjit, our President, to write about some memories which I can trace back to my college days, I would refer to one or two incidents which shaped my career as a Senior Advocate in the Supreme Court. Dr. S.S. Sareen, my Business Law Professor, who evinced interest in me towards Law and to pursue it as a career. The other one



is Professor Sydney Reberio, who was in-charge of the English debating society which inculcated in me and trained me as a persuasive speaker which helped me to shape my career.

Actor


